## Consumer Disclosure (2023): Licensing Requirements and Compatibility with GSAPP Curriculum

For more information on licensing requirements, including contact information for every state and U.S. territory licensing board, please see the Association of State Boards of Professional Psychology's (ASBPP) webpage [https://www.asppb.net/page/psybook]. All states require the completion of supervised predoctoral practicum hours and a predoctoral internship. These aspects are also required for the doctor of psychology degree in clinical psychology at Rutgers University - GSAPP. In addition to education requirements for the doctoral degree, however, many jurisdictions require post-doctoral professional experience. These requirements are beyond the curricular requirements described below and occur after graduation.

Note that in some jurisdictions, in addition to being licensed as a psychologist, an individual can obtain prescribing privileges. Rutgers University-GSAPP's Clinical Psy.D., program does NOT fulfill requirements for licensure as prescribing psychologists in those states and jurisdictions that allow for it. Typically, additional coursework in pharmacology is needed in addition to the doctoral degree. Note that the District of Columbia has their own regulations aside from the states listed here. Rutgers-GSAPP's Clinical Psy.D. Program meets D.C.'s requirements (see <a href="https://dchealth.dc.gov/">https://dchealth.dc.gov/</a>). Please see the ASBPP website for information about other U.S. territories and Canadian provinces.

Below, an asterisk (\*) indicates that earning a doctoral degree from a program accredited by the American Psychological Association (APA) satisfies educational requirements for licensure. Rutgers University – GSAPP (Clinical Psy.D.) is currently and has been continuously accredited by APA since 1977. <u>Licensing regulations change and it is the student's responsibility to check the jurisdiction in which they plan to practice throughout their training.</u>
