

Consumer Disclosure (2022): Licensing Requirements and Compatibility with GSAPP Curriculum in the ABA Programs

For more information on licensing requirements, including contact information for state and territory licensing boards, please see the Behavior Analyst Certification Board’s U.S. licensure of behavior analysts webpage. In addition to education requirements, many jurisdictions have additional requirements. Below, an asterisk (*) indicates that obtaining BCBA certification satisfies educational requirements for licensure.

The Association for Behavior Analysis International has verified our ABA course sequence, which is a part of our Master of Applied Behavior Analysis (MABA), Master of Applied Psychology (MAP) – ABA Track, and Certificate in ABA programs, toward the coursework requirements for eligibility to take the Board Certified Behavior Analyst® (BCBA) examination. Applicants will need to meet additional requirements before they can be deemed eligible to take the examination. BCBA certification requires the following:

1. Graduate degree from a qualifying institution
2. Coursework that is behavior-analytic in content (5th Edition Task List)
3. Supervised fieldwork
4. Pass the BCBA exam
