### Introduction

\*\*\*This form is to be used **by classes entering GSAPP in 2020-2021 and after.** This form reflects changes to the curriculum implement during 2019-2020.

This is the main body of the Program Proposal. For students who have had no previous graduate training, all the necessary pages are attached. Students who wish to transfer credits from previous graduate training must complete and attach official waiver forms, which can be obtained from the departmental secretary. When waiving coursework, you only need to attach the signed waiver form(s) and not the accompanying syllabi.

There are two basic forms and one appendix in this package.

FORM 1: lists the required courses and has space for you to indicate when you will take each course.

FORM 2: a time chart that allows you to plan your sequence of courses and practica for the years you will be at GSAPP. Form 2 is a different way of ordering the courses already listed in Form 1. Please be sure to fill in the calendar year on the top of each page. In addition, please indicate the summer in which you intend to take the comprehensive exams.

APPENDIX 1: This appendix includes a list of Effective Intervention courses - which can help you complete Form 1.

APPENDIX 2: This appendix contains a model course sequence.

Form 1 is divided into five sections:

1. Required Didactic Courses (p. 1). These include required courses which are listed on the form as well as those effective intervention courses for which choice is permitted within defined boundaries.
2. Required and Additional Electives (p. 2). Courses not already included under the categories on page 1.
3. Required Clinic, Practicum, and Internship Credits (p. 3).
4. Credit Summary Sheet (p. 4)
5. Specialty Cluster (p. 5). A list of those courses that comprise your elective specialty cluster.

## DIRECTIONS FOR FORM 1:

### PAGE 1

The first page of Form 1 lists all of the courses specifically required of all students. To the right of each course there is space to indicate when you are planning to take each at GSAPP. For each course insert the number of credits and the semester and year you are planning to take the course. If you will be waiving or transferring any credits, please denote these in the appropriate columns. Enter the sum of each type of credit to be earned at the bottom of the table.

The first page of Form 1 asks you to also list the four effective intervention courses you plan to take to meet GSAPP requirements. The effective intervention course requirement is for 4 SEMESTERS, not four courses. So year-long courses can meet two of the requirements. Note that you must take at least one course which focuses on the individual applications and one course that addresses either family, couple, or group applications from a systems viewpoint. Identify each course according to these categories in the appropriate column to the right of the course title. Be sure to include course numbers as well as titles. Because this requirement is designed to ensure that you are exposed to different modalities and strategies, make sure that no more than two of the courses you list are taught by the same professor.

### PAGE 2

The second page of Form 1 lists all additional required and optional elective courses. To meet the overall credit requirement at GSAPP, you will need to take 4 additional 3-credit courses beyond the courses listed on page 1. These courses are denoted as "Required (3 cr)" in the table.

To complete this page, list each course by title and course number and write the number or credits and semester/year you will be taking or transferring/waiving the course.

### PAGE 3

Page 3 of Form 1 lists your clinic hours, practicum hours, and internship hours. Note that the clinic hours, practicum hours, and internship hours are all given regular academic credits. For each course insert the number of credits and the semester and year you are planning to take or transfer/waiving the course.

### PAGE 4

Summarize the number of credits to transfer, waived, and to earn that was tallied on pages 1-3.

### PAGE 5

The Worksheet for Form 1 asks you to list your specialty cluster choices. A cluster is defined as a set of *three or more* courses which adhere to a coherent theme. It may overlap totally with the 12 required application credits or may differ. If desired, clusters may be created by the student in consultation with his/her advisor. Note: Your cluster title is included only for the purposes of your planning and communication with advisors. This title will not be reflected on any official Rutgers documents.

Think about what you want to study in more depth at GSAPP, and then write down the courses that correspond to that focus. Provide your own cluster title for this choice of courses. Courses listed here should also appear on Pages 1 and/or 2.

\*\* Sample Cluster Titles: child assessment and therapy, community interventions, general practice, psychoanalytic therapy, adult interventions, severe and persistent mental illness, applied behavior analysis.

<sup>a</sup> **General GSAPP Clinic credit:** As outlined in the Student Handbook, students are required to see assessment and therapy cases through the GSAPP General Clinic. In each Fall and Spring semester of years 1, 2, and 3, students will enroll for 0.5 credits (total = 3 credits) to reflect this work. Students should not count cases seen as part of internal practica (e.g., DBT, PACT, YAD-C) to count for these credits. After year 3, students will register for .5 General GSAPP Clinic credits for each semester he or she is seeing any therapy or assessment client in the GSAPP General Clinic.

\* 1<sup>st</sup>-year Clinic: accounts for cases seen for Foundation courses and any other assessment, therapy cases seen.

\*\* 2<sup>nd</sup>-year Clinic: Plan half-day commitment that will include a combination of assessment and therapy. 2<sup>nd</sup>-yr students will get priority for assessment cases (est. ≥ 2).

\*\*\* ≥ 3<sup>rd</sup>-year Clinic: 3<sup>rd</sup>-year students are required to see therapy/assessment cases. For any years after 3<sup>rd</sup>-year, register for .5 credits in any semester you are seeing cases/assessments.

<sup>b</sup> **Practicum credit:** Students register for 3 practicum credits for each Fall and Spring semester he/she is participating in a practicum (internal or external). Each 1-day per week practicum assumes 120 hours (8 hours per week over one semester or the equivalent) of work in a practicum setting. Each 2-day per week practicum will assume 240 hours (16 hours per week over one semester or the equivalent) of work in a practicum setting. Students will register for Practicum credits for internal practica (e.g., DBT, PACT, YAD-C) or external practica. Students registered for both an internal and external practica still only register for 3 credits. \*\*Only 4 years of practicum are required for graduation, but students who participate in a practicum during their 5<sup>th</sup> year (or beyond), must register for 3 credits of Practicum in each semester they enroll.

<sup>c</sup> **Internship in Clinical Psychology credits:** Students enroll for 3 credits in the Fall and Spring semester of their internship year. Internship requires 1750 hours (one full year or the equivalent) of work.

\*\*\* **Transfer of practicum credits:** 3 credits for each of two semesters may be waived (6.0 total) by approval of the Department Chair.
