Overview

 - Amount: Up to \$4,500
 - Type: Dissertation/Research Expense Reimbursement

Clinical Department: The scholarship is intended for a student whose dissertation pertains to effective psychological services focused on health promotion that is relevant, but not necessarily limited in its application, to the independent practice of psychology in the private sector. Examples are research on interventions related to the interface of psychology and primary care medicine, on collaborative approaches between psychologists and other types of health practitioners, on cross-cultural issues in immigrant families related to psychological and physical health, and so forth.
